1. Important

This electronic user's guide is intended for anyone who uses the Philips monitor. Take time to read this user manual before you use your monitor. It contains important information and notes regarding operating your monitor.

The Philips guarantee applies provided the product is handled properly for its intended use, in accordance with its operating instructions and upon presentation of the original invoice or cash receipt, indicating the date of purchase, dealer's name and model and production number of the product.

1.1 Safety precautions and maintenance

Warnings

Use of controls, adjustments or procedures other than those specified in this documentation may result in exposure to shock, electrical hazards and/or mechanical hazards.

Read and follow these instructions when connecting and using your computer monitor.

Operation

- Please Keep the monitor out of direct sunlight, very strong bright lights and away from any other heat source. Lengthy exposure to this type of environment may result in discoloration and damage to the monitor.
- Remove any object that could fall into ventilation holes or prevent proper cooling of the monitor's electronics.
- Do not block the ventilation holes on the cabinet.
- When positioning the monitor, make sure the power plug and outlet are easily accessible.
- If turning off the monitor by detaching the power cable or DC power cord, wait for 6 seconds before attaching the power cable or DC power cord for normal operation.

- Please use approved power cord provided by Philips all the time. If your power cord is missing, please contact with your local service center. (Please refer to Customer Care Consumer Information Center)
- Do not subject the monitor to severe vibration or high impact conditions during operation.
- Do not knock or drop the monitor during operation or transportation.

Maintenance

- To protect your monitor from possible damage, do not put excessive pressure on the LCD panel. When moving your monitor, grasp the frame to lift; do not lift the monitor by placing your hand or fingers on the LCD panel.
- Unplug the monitor if you are not going to use it for an extensive period of time.
- Unplug the monitor if you need to clean it with a slightly damp cloth. The screen may be wiped with a dry cloth when the power is off. However, never use organic solvent, such as, alcohol, or ammonia-based liquids to clean your monitor.
- To avoid the risk of shock or permanent damage to the set, do not expose the monitor to dust, rain, water, or excessive moisture environment.
- If your monitor gets wet, wipe it with dry cloth as soon as possible.
- If foreign substance or water gets in your monitor, please turn the power off immediately and disconnect the power cord. Then, remove the foreign substance or water, and send it to the maintenance center.
- Do not store or use the monitor in locations exposed to heat, direct sunlight or extreme cold.
- In order to maintain the best performance of your monitor and use it for a longer lifetime, please use the monitor in a location that falls within the following temperature and humidity ranges.

Important

• Temperature: 0-40°C 32-95°F

• Humidity: 20-80% RH

• IMPORTANT: Always activate a moving screen saver program when you leave your monitor unattended. Always activate a periodic screen refresh application if your monitor will display unchanging static content. Uninterrupted display of still or static images over an extended period may cause "burn in", also known as "after-imaging" or "ghost imaging", on your screen.

"Burn-in", "after-imaging", or "ghost imaging" is a well-known phenomenon in LCD panel technology. In most cases, the "burned in" or "after-imaging" or "ghost imaging" will disappear gradually over a period of time after the power has been switched off.

Warning

Failure to activate a screen saver, or a periodic screen refresh application may result in severe "burn-in" or "after-image" or "ghost image" symptoms that will not disappear and cannot be repaired. The damage mentioned above is not covered under your warranty.







2 Install base stand

1. Place the monitor face down on soft and smooth surface taking care to avoid scratching or damaging the screen.




- 2. Hold the base stand with both hands and firmly insert the base stand into the base column.
 - (1) Gently attach the base to the base column until the latch locks the base.
 - (2) Use your fingers to tighten the screw located at the bottom of the base, and secure the base to the column tightly.


- 1. Connect the power cord to the back of the monitor firmly.





Description of the On Screen Display

What is On-Screen Display (OSD)?

On-Screen Display (OSD) is a feature in all Philips LCD monitors. It allows an end user to adjust screen performance or select functions of the monitors directly through an on-screen instruction window. A user friendly on screen display interface is shown as below:




Basic and simple instruction on the control keys


3 Resolution notification

2.3 MHL (Mobile High-Definition Link) introduction

1 What is it?

Mobile High Definition Link (MHL) is a mobile audio/video interface for directly connecting mobile phones and other portable devices to high-definition displays.

An optional MHL cable allows you to simply connect your MHL capable mobile device to this large Philips MHL display, and watch your HD videos come to life with full digital sound. Now not only you can enjoy your mobile games, photos, movies, or other apps on its big screen, you can simultaneously charge your mobile device so you never run out of power half way.


2 How do I use the MHL function?

To use the MHL function, you need an MHL-Certified mobile device. To find a list of MHL-certified devices, visit the official MHL website (http://www.mhlconsortium.org)

You also need a optional MHL certified special cable in order to use this function.

3 How does it work? (how do I connect?)

Connect the Optional MHL cable to the mini USB port on the mobile device side, and the [MHL-HDMI] marked port on the monitor side. You are now ready to view the images on your big screen display and operate all function on you the mobile device such as internet surfing, game playing, photo browsing...etc. if your monitor has speaker function, then you will be able to hear accompanying sound too. When the MHL cable is disconnected or the mobile device is turned off, the MHL function will be automatically disabled.



Note

- The port marked [MHL-HDMI] is the only port on the monitor that supports the MHL function when the MHL cable is used. Note that the MHL certified cable is different than a standard HDMI cable.
- A mobile device with MHL certification must be purchased separately
- You may have to manually switch the monitor to MHL-HDMI mode in order to activate the monitor, if you have other devices already working and connected to available inputs


2 Why do I need it?

You want a monitor that delivers optimized display all your favorite types of content, SmartImage Lite software dynamically adjust brightness, contrast, color and sharpness in real time to enhance your monitor viewing experience.

3 How does it work?

SmartImage Lite is an exclusive, leading edge Philips technology that analyzes the content displayed on your screen. Based on a scenario you select, SmartImage Lite dynamically enhances the contrast, color saturation and sharpness of images to enhance the contents being displayed - all in real time with the press of a single button.


4 How to enable SmartImage Lite?



- 1. Press **t** to launch the SmartImage Lite on screen display;
- 2. Keep pressing to toggle between Standard, Internet, Game.

3.2 SmartContrast

1 What is it?

Unique technology that dynamically analyzes displayed content and automatically optimizes a LCD monitor's contrast ratio for maximum visual clarity and viewing enjoyment, stepping up backlighting for clearer, crisper and brighter images or dimming backlighting for clear display of images on dark backgrounds.

2 Why do I need it?

3.3 Philips SmartControl Lite

The new SmartControl Lite software by Phillips allows you to control your monitor via an easy to use on-screen graphic interface. Complicated adjustments are a thing of the past as this user friendly software guides you through finetuning resolution, Color calibration, Clock/Phase adjustments, RGB White point adjustment, etc.

1 Installation

- You can launch after installation is completed.
- If you want to launch later, you can either click the shortcut on desktop or toolbar.








- 1. "Show Me" starts color calibration tutorial.

Allows user to change setting for better display setting based on content.

When Entertainment is set, SmartContrast and SmartResponse are enabled.



Options>Preferences - Will only be active when selecting Preferences from the dropdown Options menu. On a non-supported display capable of DDC/Cl, only the Help and Options tabs are available.



- Displays current preference settings.
- A checked box enables the feature. The check box is a toggle.
- Enable Context Menu on desktop is checked (On) by default. Enable Context menu displays SmartControl Lite selections for Select Preset and Tune Display in the desktop right-click context menu. Disabled removes SmartControl Lite from the right click context menu.
- Enable Task Tray icon is checked (On) by default. Enable context menu shows the task tray menu for SmartControl Lite. A right click on the task tray icon displays the menu options for Help, Technical Support, Check for Update, About, and Exit. When Enable task tray menu is disabled, the task tray icon will only display EXIT.
- Run at Startup is checked (On) by default. When disabled, SmartControl Lite will not launch at start or be in the task tray. The only way to launch SmartControl Lite is either from the desktop short cut or from the program file. Any preset set to run at startup will not load when this box is unchecked (Disabled).
- Enable transparency mode (Windows 7, Windows 8). Default is 0% Opaque.

Options>Input - Will only be active when selecting Input from the drop-down Options menu. On a non-supported display capable of DDC/Cl, only the Help and Options tabs are available. All other SmartControl Lite tabs are not available.



- Display the Source instruction pane and current input source setting.
- On single input displays, this pane will not be visible.

Options>Audio - Will only be active when selecting Audio from the drop-down Options menu.

On a non-supported display capable of DDC/CI, only the Help and Options tabs are available.



Help>User Manual - Will only be active when selecting User Manual from the drop-down Help menu. On a non-supported display capable of DDC/Cl, only the Help and Options tabs are available.



Help>Version - Will only be active when selecting Version from the drop- down Help menu. On a non-supported display capable of DDC/Cl, only the Help and Options tabs are available.

Context Sensitive menu

The Context Sensitive menu is Enabled by default. If Enable Context Menu has been checked in the Options>Preferences pane, then the menu will be visible.




The Context Menu has four entries:

- SmartControl Lite When selected the About Screen is displayed.
- Select Preset Provides a hierarchical menu of saved presets for immediate use. A check mark shows the currently selected preset. Factory Preset can also be called from the drop down menu.
- Tune Display Opens the SmartControl Lite control panel.
- SmartImage Lite Check current settings, Standard, Internet, Game.

Task Tray Menu Enabled

The task tray menu can be displayed by rightclicking on the SmartControl Lite icon from the task tray. Left Click will launch the application.



The task tray has five entries:

Help - Access to User Manual file: Open User Manual file using the default browser window.

- Technical Support displays the tech support page.
- Check for Update takes the user to PDI Landing and checks the user's version against the most current available.
- About Displays detailed reference information: product version, release information, and product name.
- Exit Close SmartControl Lite.

To run SmartControl Lite again either select SmartControl Lite from Program menu, doubleclick the desktop PC icon or restart the system.



Task Tray Menu Disabled

When the Task Tray is disabled in the preference folder, only the EXIT selection is available. To completely remove SmartControl Lite from the task tray, disable Run at Startup in Options>Preferences.



4. Built-in Webcam with Microphone

Note

USB connection between the monitor and PC is required for the webcam to operate.

The webcam allows you to hold interactive video and audio conference calls over the internet. It provides the most convenient and easiest way for Business persons to communicate with other colleagues around the world, saving a lot time and money. Depending on the software used, it also allows you to take photos, share files or use microphone only without enabling webcam. The microphone and activity light are on the side of the webcam on the bezel of the display.




4.1 PC system requirements

- Operating system: Microsoft Windows 7, Microsoft Windows Vista, Microsoft Windows XP (SP2), and any other OS whichever support UVC/UAC (USB Video Class compliant / Audio Class compliant) under USB 2.0 standard
- Processor: 1.6GHz or above
- RAM: 512MB (for XP) / 1GB(for Vista and Windows7)
- Hard disk space: minimum 200MB
- USB: USB 2.0 or above, UVC/UAC support

4.2 Using the device

Philips monitor with webcam device transmits video and sound data through USB port. It can be enabled by simply connecting your USB cable from your PC to the USB upstream of USB hub on the side IO of monitor.



- 1. Connect your USB cable to upstream of USB hub on the side IO of monitor from PC side.
- 2. Turn on your PC and make sure your internet connection is working properly.
- 3. Download and enable free online chatting software such as Skype, Internet Messenger, or equivalent. You can also subscribe to dedicated software in case of more sophisticated usage like multi conferencing, etc.
- 4. The webcam is ready to be used for chat or make the phone call through internet service.
- 5. Make the call by following the instruction of the software program.

Note

To set up a video call, you must have a reliable Internet connection, an ISP, and software like Internet messenger or video phone call program. Make sure the person that you are calling has compatible video-calling software. The video and audio performance quality depends on the bandwidth available on both ends. The person you are calling must have similar capability of devices and software.





However, pixel or sub pixel defects on the TFT Monitor panels used in flat panel monitors are sometimes unavoidable. No manufacturer can guarantee that all panels will be free from pixel defects, but Philips guarantees that any monitor with an unacceptable number of defects will be repaired or replaced under warranty. This notice explains the different types of pixel defects and defines acceptable defect levels for each type. In order to qualify for repair or replacement under warranty, the number of pixel defects on a TFT Monitor panel must exceed these acceptable levels. For example, no more than 0.0004% of the sub pixels on a monitor may be defective. Furthermore, Philips sets even higher quality standards for certain types or combinations of pixel defects that are more noticeable than others. This policy is valid worldwide.



Pixels and Sub pixels


A pixel, or picture element, is composed of three sub pixels in the primary colors of red, green and blue. Many pixels together form an image. When all sub pixels of a pixel are lit, the three colored sub pixels together appear as a single white pixel. When all are dark, the three colored sub pixels together appear as a single black pixel. Other combinations of lit and dark sub pixels appear as single pixels of other colors.

Types of Pixel Defects


Pixel and sub pixel defects appear on the screen in different ways. There are two categories of pixel defects and several types of sub pixel defects within each category.

Bright Dot Defects







Because pixel and sub pixels defects of the same type that are near to one another may be more noticeable, Philips also specifies tolerances for the proximity of pixel defects.

9.1 Troubleshooting

This page deals with problems that can be corrected by a user. If the problem still persists after you have tried these solutions, contact Philips customer service representative.

1 Common Problems

No Picture (Power LED not lit)

- Make sure the power cord is plugged into the power outlet and into the back of the monitor.
- First, ensure that the power button on the front of the monitor is in the OFF position, then press it to the ON position.

No Picture (Power LED is White)

- Make sure the computer is turned on.
- Make sure the signal cable is properly connected to your computer.
- Make sure the monitor cable has no bent pins on the connect side. If yes, repair or replace the cable.
- The Energy Saving feature may be activated

Screen says



- Make sure the monitor cable is properly connected to your computer. (Also refer to the Quick Start Guide).
- Check to see if the monitor cable has bent pins.
- Make sure the computer is turned on.

AUTO button doesn't function

• The auto function is applicable only in VGA-Analog mode. If the result is not

satisfactory, you can do manual adjustments via the OSD menu.



The Auto Function is not applicable in DVI-Digital mode as it is not necessary.

9.2 SmartControl Lite FAQs

Q1. I change the monitor on a PC to a different one and the SmartControl Lite becomes un-usable, what do I do?

Ans.: Restart your PC and see if SmartControl Lite can work. Otherwise, you will need to remove and re-install SmartControl Lite to ensure proper driver is installed.

Q2. The SmartControl Lite functions worked well before, but it does not work anymore, what can I do?

Ans.: If the following actions were executed, the monitor driver may need to be reinstalled.

- Changed video graphic adapter to another one
- Updated video driver
- Activities on OS, such as service pack or patch
- Run Windows Update and updated monitor and/or video driver
- Windows was booted with the monitor power off or disconnected.

- If you see "Plug and Play Monitor" shows under Monitor, then you need to re-install.
 Simply remove SmartControl Lite and re-install it.
- Q3. After installing SmartControl Lite, when clicking on SmartControl Lite tab, nothing shows up after a while or a failure message shows, what happened?

Ans.: It might be your graphic adaptor is not

compatible with the SmartControl Lite. If your graphic adaptor is one of the above mentioned brands, try to download the most updated graphic adaptor driver from corresponding companies' web site. Install the driver. Remove SmartControl Lite, and re-install it once more. If it is still not working, we are sorry that the graphic adaptor is not supported. Q4. When I click on Product Information, only partial information is shown, what happened?

Ans.: It might be your graphic card adaptor driver is not the most updated version which fully supporting DDC/CI interface. - In the Windows Start Menu, select Settings/ Control Panel. In the Control Panel Window, select the Display icon. Inside the Display Control Panel, select the 'Settings' tab. Under the setting tab, in box labelled 'desktop area', move the sidebar to 1920×1080 pixels.
- Open 'Advanced Properties' and set the Refresh Rate to 60Hz, then click OK.
- Restart your computer and repeat step 2 and 3 to verify that your PC is set at 1920x1080@60Hz.
- Shut down your computer, disconnect your old monitor and reconnect your Philips I CD monitor.
- Turn on your monitor and then turn on your PC.

Q2: What is the recommended refresh rate for LCD monitor?

Q1: I cannot see my mobile device image on the monitor screen

Ans.:

- Please check if your mobile device is MHL certified.
- You also need to have a MHL certified cable to connect the devices.
- Make sure that you have connected to the MHL-HDMI port, and that correct input is selected on the Monitor via the input selector (front bezel or OSD)
- The product is officially MHL-certified. As this monitor is a passive display, if you encounter any unexpected troubles when using the MHL input, please refer to the mobile device's user manual or contact the manufacturer of the mobile device.



 Make sure your mobile device has not entered standby (sleep) mode. If it has, then you will see a notification message on the display. Once the mobile device wakes up, the monitor's display will wake and show the images. Q2. Why is the image on the monitor display of poor quality? My mobile device looks far better.

- The image quality depends on the quality of the original contents. If the content is of high resolution (example HD or 1080p), then it will appear in HD or 1080p on this monitor display. If the original content is in low resolution (example QVGA) it may look good on the mobile device due to its small screen size, but will look to be of lower quality on the large screen monitor display.

Q3. I cannot hear sound from the monitor display.

Ans.:

- Make sure your monitor display has builtin speakers and the volume is turned on the monitor side, and also on the mobile device side. You may also want to use optional headphones.
- If your monitor display does not have in built speakers, then you can connect optional headphones to the output on the monitor. Please ensure that the volume is turned on the monitor side, and also on the mobile device side.
